CITY / TOWN ORDINANCES AND RESTRICTIONS												
Atlantic Beach, Carteret County												
The entire area within the corporate limits is a Bird Sanctuary. It is unlawful to trap, hunt, shoot or attempt to shoot or molest in any manner any bird, or wild fowl or to rob bird nests or wild fowl nests within the town.												
Keeping of livestock and poultry is prohibited. Leash law, dog license required												
Carolina Beach, New Hanover County												
Leash law; dog license required. It is unlawful to keep or harbor any animal or fowl not considered a "commonly accepted domestic animal or fowl" within the jurisdictional limits of the town.												
City of Charlotte, Mecklenburg County												
License fees include ferrets. Permits required to keep any livestock or fowl; limit 20 fowl/rabbits per acre. Permit required to keep more than 3 dogs, cats or combination outside.												
Exotic animals prohibited. Animals prohibited from any city-sponsored events.												
City of Concord, Cabarrus County												
It is unlawful to keep cattle, sheep, goats, domestic fowl, or swine within city limits												
City of Dunn, Harnett County												
License required for dogs. Unlawful to keep hogs, swine. Unlawful to keep bees. The entire area embraced within the corporate limits of the city is hereby designated as a bird sanctuary.												
Unlawful to keep more than 2 rabbits; must be kept more than 50 ft from any dwelling for human habitation.												
Town of Emerald Isle, Carteret County												
The entire town is a sea turtle sanctuary and a bird sanctuary. It is unlawful for any person to have or possess within the town horses, cattle, hogs, goat, fowl, and other livestock except by permit.												
Leash law; license required. Nuisance and pooper scooper law for dogs.												
Town of Garner, Wake County												
One time license fee of \$25 for dogs, cats. The entire area inside corporate town limits is designated as a bird sanctuary. Inherently dangerous animals prohibited.												
It shall be unlawful for any person to keep or maintain more than two (2) dogs over 5 months of age on any lot or parcel of land having less than 20,000 SF												
Inherently dangerous animals (cited as wolf and cat hybrids, undomesticated cats over 15 pounds, and bears)												
Town of Hickory, Catawba/Caldwell Counties												
Leash law. Keeping of hogs, pigs, swine and goats within the corporate limits is, for the protection of the public health, prohibited. One goat or one pig may be kept as a family pet under certain conditions.												
The area embraced within the corporate limits and all parks and grounds used for municipal purposes are hereby declared a sanctuary for the protection of birds.												
City of High Point, Guilford County												
Leash law; dog license required.												
Town of Hope Mills, Cumberland County												
Kennels require special zoning permits. No person shall keep on any one lot or premises within the corporate limits more than three dogs or three cats.												
No person shall keep, possess, or maintain, within the town, any horse, mule, pony, cow, cattle, hog, swine, sheep or goat on any lot, parcel, or tract of land less than two acres in size.												
It shall be unlawful for any person notwithstanding subsection (a) of this section to keep in excess of one horse, pony, mule, cow, hog, swine, sheep, or goat, and ten chickens per acre.												
Any horses, mules, or ponies maintained within the town's residential zoning area shall be registered with the town on January 1 of each year, and an annual license fee shall be paid to the town.												
Riding is restricted in certain areas. Privilege license required for dogs, cats.												
Town of Kernersville, Forsyth County												
The entire area within corporate limits of the town is designated as a bird sanctuary.

The area embraced within the corporate limits of the city and all lands owned or leased by the city outside the corporate limits are hereby designated as a bird sanctuary.												
Leash law. It is unlawful to keep hogs, goats, or sheep within city corporate limits. It is unlawful to keep more than 10 rabbits within city corporate limits; hutch construction specified.												
City of Kinston, Lenoir County												
City corporate and territorial limits are designated as a bird sanctuary. Keeping of livestock within city limits is prohibited. Identification tags required for dogs.												
City of Laurinburg, Scotland County												
Leash law for dogs. Dogs may only be tethered one hour out of every 24. Dogs must be licensed and registered. It is unlawful to keep pigs, hogs, goats, chickens, domesticated ducks within city limits.												
All territory within city limits is designated as a bird sanctuary.												
City of Lexington, Davidson County												
All territory within city limits is designated as a game and bird and wildlife preserve and sanctuary.												
It shall be unlawful for any person to own, to keep custody of or to take care of more than three (3) dogs four (4) months or older, on any residential zoned lot.												
This applies to single-family residences and duplexes. It is unlawful in multi-unit buildings to keep more than one (1) outside animal per unit.												
Animals shall be in an area as designated by the owner of the property. Single-family homes, duplexes, attached single-family homes are exempt.												
It shall be unlawful to own, to keep custody of or to take care of four (4) or more chickens, rabbits or fowl or other small animals of any one type and a total of any combination of eight (8).												
The number of livestock is limited to one (1) animal per two (2) acres of pasture with a maximum of five (5). Bona fide farms are exempt.												
City of Lumberton, Robeson County												
The territory within city limits is declared a bird sanctuary. Bee keeping is prohibited. No more than 3 dogs per owner within city limits. No more than 4 cats per owner within city limits.												
Dog license required annually; must be affixed to collar. Cat license (and collar) required. Nuisance law for dogs & cats.												
License required to keep pot bellied pigs. Permits required for horses.												
Town of Manteo, Dare County												
All area within town limits is designated a bird sanctuary. Dogs at large prohibited. Identification tag required. Vicious animals prohibited. Livestock prohibited.												
Town of Matthews, Mecklenburg County												
License required for dogs, cats, ferrets; differential fee \$10 sterile / \$30 fertile. Permit required to keep more than 4 dogs or cats.												
Permit required to own any equine animals, cloven-hoofed animals or livestock, chickens, turkeys, geese, pheasants, pigeons, domestic fowl. Limit of 20 rabbits or fowl per acre.												
City of Mebane, Alamance County												
The area embraced within the corporate limits of the city and all lands owned or leased by the city outside the corporate limits are hereby designated as a bird sanctuary.												
City of Mount Airy, Surry County												
The area embraced within the corporate limits of the city and all lands owned or leased by the city outside the corporate limits are hereby designated as a bird sanctuary.												
It shall be unlawful for any person with less than 10 acres of land to keep swine, horses, mules, cattle, goats, sheep or other livestock within the corporate limits.												
Town of Oak Island, Brunswick County												
Registration tags required for dogs. Running at large prohibited; misdemeanor offense.												
Area within corporate limits is declared a bird sanctuary. Specific defined area of dunes is designated as a sea turtle sanctuary. Unlawful to feed alligators within corporate limits.												
City of Randleman, Randolph County												
All dogs kept, harbored or maintained by their owners in the city must be licensed and registered												
Keeping of hogs, pigs, pot bellied pigs or swine within corporate limits is declared a nuisance to adjoining property owners and to the public and is prohibited.

Dogs to wear identification and rabies tags. Cats to wear identification and collar. Inherently dangerous animals prohibited.												
Town of Selma, Johnston County												
License and registration required; \$2 fee. It is unlawful for any person to have or keep more than three (3) dogs or cats, six (6) months or older on any tract within town limits.												
Unlawful to keep livestock or fowl within corporate limits except in conjunction with business that is permitted as special or conditional use within zoning district.												
Town of Sylva, Jackson County												
Leash law for animals; does not apply to cats. The entire area within corporate limits is designated as a bird sanctuary.												
City of Thomasville, Davidson County												
A bird sanctuary exists with the territorial limits of the City. Keeping swine prohibited.												
Dogs running at large prohibited. Permit required for dog breeding. Permit required to own/maintain more than 3 dogs. Dog pens must be a minimum of 25 ft from adjacent property boundary												
Town of Waynesville, Haywood County												
The entire area within corporate limits of the town is designated as a bird sanctuary. Swine prohibited within city limits.												
City of Winston-Salem, Forsyth County												
It shall be unlawful for any person to keep more than ten rabbits of breeding age within the corporate limits of the city; hutch construction defined.												
Nuisance if fowl or dogs crow, cackle, bark, whine, howl for more than 15 minutes. Dogs must be restrained to owners property; running at large prohibited.												
Sanitation requirements for dogs; feces to be picked up daily; kept in tight fitting container and disposed after interval no longer than 5 days.
